- (1) The Common Stock was acquired upon the conversion of Restricted Stock Units ("RSUs") in accordance with the terms of the underlying agreement. The RSUs were granted in a transaction exempt under Rule 16b.
 - (2) RSUs granted under the Hexcel Corporation 2008 Incentive Stock Plan in a transaction exempt under Rule 16b.
 - (3) The RSUs vest ratably over the one year following the grant date which was May 8, 2008, and convert into an equal number of shares of common stock on the first anniversary of the grant date unless the grantee elected to defer conversion until such time as the grantee ceases to be a member of Hexcel's Board. Vesting and conversion are subject to certain acceleration and termination provisions.

- The RSUs vested one-third on grant and one-third on each of the first and second anniversaries of the grant date, and converted into an equivalent number of shares of Common Stock on the second anniversary of the grant date. The grant date was two years prior to the expiration date.
