- (1) Vesting of Restricted Stock Units (RSUs) granted to the Reporting Person on December 14, 2014.

All of the shares reported as disposed of on this line were relinquished by the Reporting person and cancelled by the issuer in exchange for the Issuer's agreement to pay federal and state tax withholding obligations of the Reporting person resulting from the vesting of the RSUs.
