- (1) The shares acquired represent the vesting and automatic settlement of 2894 of the Reporting Person's restricted stock units on September 1, 2016.
 - (2) Represents shares withheld in connection with the payment of withholding taxes due upon vesting and settlement of restricted stock units.
 - (3) The shares acquired represent the vesting and automatic settlement of 3614 of the Reporting Person's restricted stock units on September 1, 2016.
 - (4) The shares acquired represent the vesting and automatic settlement of 1141 of the Reporting Person's performance restricted stock units on September 1, 2016.
 - (5) The shares acquired represent the vesting and automatic settlement of 1804 of the Reporting Person's performance restricted stock units on September 1, 2016.
 - (6) Each restricted stock unit represents a contingent right to receive one share of Boingo Wireless, Inc. common stock.
On March 3, 2014, the Reporting Person was granted 34,727 restricted stock units, vesting in a series of twelve successive equal quarterly installments beginning on March 1, 2014, so that the restricted stock units will become fully vested on March 1, 2017. The restricted stock units are settled in shares of common stock that will be delivered to the Reporting Person shortly after each vesting date.
 - (7) On February 27, 2015, the Reporting Person was granted 43,369 restricted stock units, vesting in a series of twelve successive equal quarterly installments beginning on March 1, 2015, so that the restricted stock units will become fully vested on March 1, 2018. The restricted stock units are settled in shares of common stock that will be delivered to the Reporting Person shortly after each vesting date.
 - (8) Following determination of achievement of 2014 performance goals, the Reporting Person received 13683 performance restricted stock units, vesting with respect to 1/3 of such units on March 1, 2015, and with respect to the balance in a series of eight successive equal quarterly installments thereafter, so that the performance restricted stock units will become fully vested on March 1, 2017
 - (9) Following determination of achievement of 2015 performance goals, the Reporting Person received 21650 performance restricted stock units, vesting with respect to 1/3 of such units on March 3, 2016, and with respect to the balance in a series of eight successive equal quarterly installments thereafter, so that the performance restricted stock units will become fully vested on March 3, 2018
