**Item 7.01. Regulation FD Disclosure**

On May 14, 2009, Casey's General Stores, Inc. (the "Company") reported April 2009 same-store sales results for stores open for one full year. Same store gasoline gallons sold increased 2.2% in April 2009 compared to April 2008. The gasoline margin was in line with the Company's fiscal 2009 goal of 10.8 cents per gallon. The average retail price of gasoline sold during April 2009 was \$1.93 per gallon. Same-store sales for prepared food and fountain increased 8.0% and grocery and other merchandise increased 8.7% in April 2009 compared to April 2008. Approximately 5% of the grocery and other merchandise increase was related to cigarettes, primarily due to the federal excise tax increase.
