The net result was each previously outstanding share of common stock converted into 1/10 of a share of each of Class A, Class B-1, Class B-2, and Class B-3 common stock. On April 5, 2013, the Class B-2 common stock automatically converted into Class A common stock on a one-for-one basis.

 - (3) The Class B-2 common stock automatically converted into Class A common stock on April 5, 2013 on a one-for-one basis.
