- (1) Includes 90 Ordinary Shares purchased by the Reporting Person on July 31, 2014 under the Issuer's Employee Stock Purchase Plan. Such acquisition is exempt from reporting pursuant to Rule 16b-3 under the Securities Exchange Act of 1934.  

These Ordinary Shares were sold in multiple transactions at sales prices ranging from \$60.85 to \$60.96, inclusive.
