Item 3.02 Unregistered Sales of Equity Securities

On May 22, 2015, the Registrant accepted a conversion notice from WHC Capital, LLC ("WHC") to partially satisfy a \$55,000 Convertible Promissory Note Agreement ("the WHC Note") dated April 21, 2014, with WHC. 8,726,388 shares were subsequently issued to satisfy \$1,833 of the outstanding principal and interest in accordance with the terms of the WHC Note. As of the date of this report the remaining amount currently outstanding on the WHC Note is now \$20,368.

On May 22, 2015, the Registrant accepted a conversion notice from LG Capital Funding LLC ("LG") to partially satisfy a \$33,000 Promissory Note ("the LG Note #2") dated February 3, 2014, with LG. 16,398,666 shares were subsequently issued to satisfy \$3,444 of the outstanding principal and interest in accordance with the terms of the LG Note #2. As of the date of this report the remaining amount currently outstanding on the LG Note #2, including accrued interest, is now \$22,510.

WHC and LG are each an "accredited investor" as defined under Rule 501 of Regulation D. The Company believes that these transactions are exempt from registration with the Securities and Exchange Commission pursuant to Section 4(2) of the Securities Act of 1933, as amended.

The above described executed Notes are attached hereto and incorporated by reference as Exhibits 10.1 through 10.2.

As of the date of this report the Registrant has 191,690,940 shares of its common stock issued and outstanding and 191,532,830 shares in the public float.
