Unilever NV announces that on 3 October 2005, it purchased 80,711 Unilever NV ordinary shares at prices between EUR59.55 and EUR59.80 per share. The purchased shares will be held as treasury shares.

Following the above purchase, Unilever NV together with subsidiary companies, holds 19,793,271 Unilever NV ordinary shares in treasury, and has 551,782,629 Unilever NV ordinary shares in issue (excluding treasury shares).
