Unilever NV also announces that 13,014 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 99,176,784 Unilever NV ordinary shares in treasury, and has 1,615,550,916 Unilever NV ordinary shares in issue (excluding treasury shares).
