On 4 March 2013, the Directors of HSBC Holdings plc declared a fourth interim dividend for 2012 of US\$0.18 per ordinary share payable on 8 May 2013 to holders of record on 21 March 2013 on the Hong Kong Overseas Branch Register and 22 March 2013 on the Principal Register in the United Kingdom or the Bermuda Overseas Branch Register. The dividend is payable in cash in United States dollars, sterling or Hong Kong dollars, or a combination of

these currencies, with a scrip dividend alternative. The 'Market Value' for the issue of new shares under the scrip dividend alternative is:

US\$10.6452 for each new share

The 'Market Value' is the United States dollar equivalent of £7.0182 being the average of the middle market quotations for the ordinary shares on the London Stock Exchange as derived from the Daily Official List for the five business days beginning on 20 March 2013.

Dividends payable in cash in sterling or Hong Kong dollars on 8 May 2013 will be converted from United States dollars at the forward exchange rates quoted by HSBC Bank plc in London at or about 11.00am on 29 April 2013. These exchange rates will be announced to the London, Hong Kong, New York, Paris and Bermuda stock exchanges.

Particulars of the dividend arrangements will be sent to shareholders on or about 3 April 2013 and elections must be received by the Registrars by 25 April 2013.
