American Realty Investors, Inc. ("ARI") is unable to file its Quarterly Report on Form 10-Q for the quarter ended March 31, 2003, without unreasonable effort and expense due to the initial consolidation activities required subsequent to the completion of a tender offer for certain affiliate companies late in the period.

Form 12b-25, Part IV(3) - Other Information

For the three months ended March 31, 2002, ARI had a net loss of \$8.9 million. For the current period ended March 31, 2003, ARI is estimated to have net income of approximately \$7.3 million due to increased gains on property sales compared to the period ended March 31, 2002.
