**REPORT ON FORM 6-K**

Attached is an English translation of the summary of the letter dated July 6, 2006 filed by the Company with the *Bolsa de Comercio de Buenos Aires* and the *Comisión Nacional de Valores*.

By letter dated July 6, 2006, the Company reported that on June 30, 2006 holders of Company's Convertible Notes that had already exercised their conversion right exercised their warrant rights. Hence, a reduction of 5,958,531 warrants and an increase of 10,933,081 ordinary shares face value pesos 1 (V\$N 1) each was made. As a result, the amount of shares of the Company goes from 424,515,429 to 435,448,510. The new amount of warrants outstanding is 50,246,008. The exercise of the warrant was performed according to terms and conditions established in the prospectus of issuance. The amount of shares acquired is equal to the amount of shares into which it was converted the convertible note at a price of US\$ 0.6541 for each share face value pesos 1. Therefore US\$ 7,151,328.60 entered into the Company.
