By letter dated April 3, 2007, the Company reported that on March 30, 2007 holders of Company s Convertible Notes that had already exercised their conversion right exercised their warrant rights. Hence, a reduction of 1,502,139 warrants and an increase of 2,756,217 ordinary shares face value pesos 1 (V\$N 1) each was made. As a result, the amount of shares of the Company goes from 450,801,365 to 453,557,582. The new amount of warrants outstanding is 44,721,735. The exercise of the warrant was performed according to terms and conditions established in the prospectus of issuance. The amount of shares acquired is equal to the amount of shares into which it was converted the convertible note at a price of US\$ 0.6541 for each share face value pesos 1. Therefore US\$ 1,802,842.43 entered into the Company.
