**DEREGISTRATION OF SECURITIES**

On June 26, 2009, pursuant to the Agreement and Plan of Merger dated as of November 14, 2008, by and among The Hartford Financial Services Group, Inc., a Delaware corporation ( Parent ), FT Acquisition Corporation, a Florida corporation and a wholly owned subsidiary of Parent ( Merger Sub ), and Federal Trust Corporation, a Florida corporation (the Company ), Merger Sub merged with and into the Company, with the Company continuing as the surviving corporation and becoming an indirect wholly owned subsidiary of Parent (the Merger ) and all outstanding shares of common stock, \$0.01 par value per share ( Common Stock ), being converted into the right to receive \$1.00 per share in cash. As a result, the Company has terminated all offerings of its Common Stock pursuant to its existing registration statements, including the Company s Registration Statement on Form S-8 (File No. 333-126462) (the Registration Statement ). In accordance with an undertaking made by the Company in its Registration Statement to remove from registration, by means of a post-effective amendment, any shares of the Company s Common Stock which remain unsold at the termination of the offering, the Company hereby removes from registration all shares of its Common Stock under the Registration Statement which remained unsold as of the effective time of the Merger.
