**Item 8.01. Other Events.**

On March 14, 2011, Windstream Corporation ( Windstream ) announced the pricing of a private placement of \$450 million aggregate principal amount of Senior Notes due 2021. A copy of the press release announcing the pricing of the offering is attached hereto as Exhibit 99.1 and is incorporated by reference herein.

In addition, on March 14, 2011, Windstream announced that it has increased the maximum amount of its 8.625% Senior Notes due 2016 that it is seeking in its previously announced tender offer to \$1,100 million from the original amount of \$600 million. A copy of the press release announcing the increase of the tender offer is attached hereto as Exhibit 99.2 and is incorporated by reference herein.
