**The Registrant recently determined that merchandise unit balances in its legacy perpetual inventory system were understated as a result of a planned but improperly executed one-time override of an automated records purge process. The resulting loss and duplication of data caused permanent inventory markdowns to be understated. The Registrant is in process of reviewing past transactions in order to correct the permanent markdowns. Until Registrant's review is complete, it is unable to complete its third quarter financial statements and file them in the Form 10-Q for the period ended October 29, 2011 by the December 8, 2011 due date.**
