1. The Company's stockholders approved a proposal to re-elect the following two Class B directors to the Company's Board of Directors, each to hold office until the 2016 annual meeting of stockholders (and until each such director's successor shall have been duly elected and qualified), with voting results as follows:

2. The Company's stockholders approved, on an advisory basis, the compensation of the Company's named executive officers for fiscal year 2012, as described in the Company's proxy statement, and cast their votes as follows:
