On May 18, 2015, Farmers National Banc Corp. ( Farmers ) issued a press release announcing that it has received all requisite regulatory approval for the proposed merger of National Bancshares Corporation ( NBOH ) with and into Farmers and the related merger of NBOH 's wholly-owned subsidiary bank, First National Bank, with and into Farmers National Bank of Canfield, Farmer 's wholly-owned subsidiary bank. A copy of the press release is attached as Exhibit 99.1 to this Current Report on Form 8-K and incorporated herein by reference.
