On March 2, 2016, LyondellBasell Industries N.V. (the Company ) and its wholly owned subsidiary, LYB International Finance II B.V. (the Issuer ), completed the underwritten public offering and sale by the Issuer of 750 million aggregate principal amount of 1.875% Guaranteed Notes due 2022 (the Notes ). The Notes are fully and unconditionally guaranteed by the Company. The Notes were issued under an indenture dated as of March 2, 2016, among the Company, the Issuer and Deutsche Bank Trust Company Americas, as trustee (the Indenture ). The terms of the Notes and the guarantee by the Company are set forth in an officer s certificate of the Issuer delivered pursuant to the Indenture (the Officer s Certificate ).
