Effective August 31, 2016, STERIS plc ("STERIS" or "Company") has sold its Applied Infection Control ("AIC") product line to DEB USA, Inc., a wholly-owned subsidiary of S.C. Johnson & Son, Inc. The Company believes that the AIC product line is better aligned with DEB, a leading provider of hand hygiene and other skin care system products to a broad group of institutional Customers around the world. Both companies believe DEB can better grow hand hygiene sales through its broad distribution channel and complimentary products. Annual revenues for the AIC product line are less than \$50 million and were reported through STERIS' s Healthcare Products Segment.
