Novo Nordisk A/S – Share repurchase programme

On 11 August 2011 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commision's regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk will repurchase B shares for an amount up to DKK 2.1 billion in the period from 11 August 2011 to 25 October 2011.

With the transactions stated above, Novo Nordisk owns a total of 19,231,697 treasury shares, corresponding to 3.3% of the share capital. The total amount of shares in the company is 580,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares worth DKK 10.0 billion during 2011. As of 26 August 2011, Novo Nordisk has repurchased a total of 12,112,053 B shares equal to a transaction value of DKK 7,371,926,666.
