 - (1) Disposed of pursuant to a merger agreement between the issuer, Inverness Medical Innovations, Inc. ("IMA") and Iris Merger Sub, Inc. in exchange for 1,535 shares of IMA Common Stock having a market value of \$48.56 per share on the effective date of the merger, and \$16.02 representing fractional shares as provided in the merger agreement.
