- Represents shares of performance based restricted stock units granted to the filing person on December 22, 2006. The vesting of the shares of performance based restricted stock units was conditioned upon the achievement of certain 2007 earnings before interest, taxes, depreciation, and amortization ("EBITDA") performance versus pre-established targets. The restricted stock units vests over three years
- (1) (1/3 on February 14, 2008; 1/3 on January 1, 2009; and 1/3 on January 1, 2010). Of the 5,770 shares of common stock, 1,923 shares were issued on February 14, 2008, of which 817 shares were withheld to satisfy payment of the Issuer's tax withholding obligation. The remaining 3,847 shares are scheduled to be issued on the two remaining vesting dates and taxes for these future issuances will be withheld at the time the shares are issued.
