- (1) The reported transaction involves an award of restricted stock under the M&T Bank Corporation 2009 Equity Incentive Compensation Plan.  
  
The restricted stock award includes a total of 2,195 shares. 658 shares of the restricted stock award will vest on January 31, 2014; an additional 659 shares will vest on January 30, 2015; and the remaining 878 shares will vest on January 29, 2016. The resulting shares of common stock received upon vesting will be subject to the restrictions on transfer included in the TARP Interim Final Rule's definition of "long-term restricted stock" until M&T repays the remainder of its TARP obligation.
- (3) The restricted stock was granted under an equity incentive compensation plan maintained by M&T Bank Corporation, and therefore the reporting person paid no price for the shares.
