- (1) The shares of Class A Common Stock represent the number of shares of restricted stock units that were granted on July 1, 2011 and vested on June 19, 2012. The shares will be delivered on August 15, 2012.  
The restricted stock units fully vest on the earlier of June 21, 2013 or the day preceding the date in calendar year 2013 on which the NeuStar, Inc. annual meeting of stockholders is held. Upon vesting, the Reporting Person shall be entitled to shares of Class A Common Stock equal to the number of vested shares of restricted stock units, including any resulting from dividend equivalents (as defined in the Restricted Stock Unit Agreement), which shall be delivered on August 15, 2013.
- (2) The restricted stock units terminate if the Reporting Person experiences a Termination (as defined in the NeuStar, Inc. 2009 Stock Incentive Plan) before the earlier of June 21, 2013 or on the day preceding the date in calendar year 2013 on which the NeuStar, Inc. annual meeting of stockholders is held.
