(1) The Reporting Person previously reported on a Form 4 filed on 01/07/2014 the vesting on 01/03/2014 of 19,291 RSUs and on 01/04/2014 the vesting of 15,961 RSUs that were paid in the form of Republic Services, Inc.'s common stock ("Common Stock"). Due to the Dividend Record date of 01/02/2014, the foregoing RSUs received dividend equivalents on the Dividend Payment Date of 01/15/2014. Therefore, a total of 284 RSUs were automatically paid out in the form of shares of Common Stock on 01/15/2014.
