Together with Wachovia, we have made significant headway with our integration planning.

"We believe First Union's strong year-to-date share price performance -- an increase of approximately 26 percent -- is the real reason behind the virtual elimination of the premium associated with SunTrust's hostile proposal.

"As we explore the exciting possibilities of this combination, we are more firmly convinced than ever that the Wachovia/First Union merger proposal offers shareholders greater near-term and long-term growth potential."
