The January 7, 2014 grant totaling 754,000 Performance Share Units (PSUs), which were subject to performance criteria set by the board of directors of the Issuer, was previously voluntarily reported on Form 4. On December 1, 2015, the performance criteria were deemed to have been met with respect to the grant at 140% of the original grant amount, increasing the award to 1,055,600 common shares.
