- a) declared a common stock dividend for the third quarter ending September 30, 2015, of \$0.12 per diluted share, payable October 15, 2015, for shareholders of record as of September 30, 2015;
- b) declared a dividend for the third quarter ending September 30, 2015, of \$0.5344 per diluted share, for the Company's 8.55% Series A Cumulative Preferred Stock. This dividend is payable October 15, 2015, for shareholders of record as of September 30, 2015;
- c) declared a dividend for the third quarter ending September 30, 2015, of \$0.5281 per diluted share, for the Company's 8.45% Series D Cumulative Preferred Stock. This dividend is payable October 15, 2015, for shareholders of record as of September 30, 2015; and
- d) declared a dividend for the third quarter ending September 30, 2015, of \$0.5625 per diluted share, for the Company's 9.00% Series E Cumulative Preferred Stock. This dividend is payable October 15, 2015, for shareholders of record as of September 30, 2015.
