Sale of Liquigás

Rio de Janeiro, June 15, 2016 – Petróleo Brasileiro S.A. – Petrobras hereby announces that it has initiated a competitive process for the sale of Liquigás Distribuidora S.A., a wholly-owned, closely-held subsidiary which operates in the bottling, distribution and sale of liquefied petroleum gas (LPG).

Liquigás is present in almost all Brazilian states, with 23 operative centers, 19 deposits, 1 storage and rail base, and a network of around 4,800 authorized resellers, with a market share of 23%.

To date, there has been no agreement confirming conclusion of the transaction and no resolutions on the matter by Petrobras' Executive Board or Board of Directors.

Any facts regarding this matter deemed to be material will be promptly disclosed to the market.
