Item 1.01 Entry into a Material Definitive Agreement.

On July 22, 2008, the Company's Board of Directors approved the form of its Indemnity Agreement and the Company entered into an Indemnity Agreement with directors Charles A. Schwan, Harry L. Casari, Robert L. Ciardella and Harold Harrigan. Additionally, the Company entered into an Indemnity Agreement with executive officers James A. Donahue, Jeffrey D. Jones and Thomas L. Green. The Indemnity Agreement provides that the Company shall indemnify each director and executive officer to the fullest extent permitted by law if such director or officer incurs any liabilities, losses or expenses arising out of a legal proceeding or investigation as a result of such director's or officer's capacity as such to the Company.
