(a) Amount Beneficially Owned:

As of the date of this filing, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), is the beneficial owner of 675,600 shares of the Company's Common Stock. Integrated Core Strategies also holds 2,352,650 warrants to purchase the Company's Common Stock ("Warrants"). Each Warrant entitles the holder to purchase one share of the Company's Common Stock at a price of \$7.50. Each Warrant will become exercisable on the later of the Company's completion of a business combination and February 14, 2009, and will expire on November 14, 2012, or earlier upon redemption. As of the date of this filing, the Company has not announced the completion of a business combination and therefore, the Warrants are not currently exercisable.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of Integrated Holding Group LP, a Delaware limited partnership ("Integrated Holding Group"), which is the managing member of Integrated Core Strategies and consequently may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Israel A. Englander ("Mr. Englander") is the managing member of Millennium Management. As a result, Mr. Englander may be deemed to have shared voting control and investment discretion over securities deemed to be beneficially owned by Millennium Management. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies.
