- (4) separation of employment from WTM, the deferred compensation account is payable in cash in ten equal annual installments that commenced on October 6, 2005. Final payment is due on October 6, 2014.
- (5) Dividends are automatically invested in Phantom Shares at the fair market price of the underlying WTM Common Shares on June 27, 2007, the date the dividends are deemed to be paid.
