(1) Inc. common stock, par value \$0.33 1/3 per share. These shares vested on December 14, 2008 based on the satisfaction of the pre-established performance measures set forth in the award documents; which are based on operating earnings before asset impairment and operating cash flow ratio.

(2) No consideration was paid for the common stock.

Restricted stock units were awarded, subject to attaining applicable performance goals, under the Dycom Industries, Inc. 2003 Long-Term Incentive Plan in December 2007. Each restricted stock unit represents a contingent right to acquire one (1) share of Dycom Industries,

(3) Inc. common stock, par value \$0.33 1/3 per share. These shares vested on December 14, 2008 based on the satisfaction of the pre-established performance measures set forth in the award documents; which are based on pre-tax income before asset impairment and operating cash flow ratio.

(4) Each restricted stock unit represents a contingent right to acquire one (1) share of Dycom Industries, Inc. common stock, par value \$0.33 1/3 per share.

(5) The restricted stock units vest in four equal annual installments beginning December 14, 2009.

(6) No consideration was paid for the restricted stock units.

(7) The options vest in four equal annual installments beginning on December 15, 2009.

(8) No consideration was paid for the derivative security.
