- (1) Each restricted stock unit represents a right to receive one share of COLM common stock.

On 6/13/2017 the reporting person was granted 1,085 restricted stock units, one-third of the restricted stock units vest annually (a) on 5/1/2018 (the "Vest Date"), and (b) on each of the two subsequent anniversaries of the Vest Date.
