- (1) Restrictions on a portion of the restricted stock granted to Mr. Robinson on February 13, 2008 have lapsed. Of the total 4,010 shares that have vested, Mr. Robinson has elected to transfer 1,335 of these shares to General Cable to satisfy tax withholding.
