- (1) The phantom stock will convert into shares of KAR common stock on a one-for-one basis.
 - (2) The reporting person will receive shares of KAR common stock, on a one-for-one basis, at a future date(s) specified by her pursuant to the deferred compensation plan.
Represents director fees deferred in the reporting person's account in the KAR Auction Services, Inc. Directors Deferred Compensation Plan. 3,168 of these shares of restricted stock were granted on 6/10/2014 at a price of \$31.57 per share and will be settled only for shares of KAR common stock on a one-for-one basis. These 3,168 shares of restricted stock were granted pursuant to the KAR Auction Services, Inc. 2009 Omnibus Stock and Incentive Plan and one-fourth of the grant vests every three months from the date of the grant and such grant is subject to forfeiture until vested.
 - (3) Reflects the reinvestment of dividend equivalents in additional shares of phantom stock pursuant to the terms of the KAR Auction Services, Inc. Directors Deferred Compensation Plan.
 - (4) Reflects dividend payment of which 23 shares are vested and the remaining shares will vest as follows: 7 shares vest on 12/9/2014, 7 shares vest on 3/9/2015 and the remaining 7 shares vest on 6/9/2015.
 - (5) Reflects dividend payment of which 20 shares are vested and the remaining shares will vest as follows: 6 shares vest on 12/9/2014, 6 shares vest on 3/9/2015 and the remaining 6 shares vest on 6/9/2015.
