(1) Between February 10, 2008 and March 13, 2008, the Reporting Person acquired 59 shares of DRE common stock through dividend reinvestment.

(2) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 10/27/2009.

(3) Represents phantom stock units accrued under the Director's Deferred Compensation Plan of Duke Realty Corporation. Between February 10, 2008 and March 13, 2008, the Reporting Person acquired 194 phantom stock units through dividend reinvestment. The units are valued on a one to one basis to the Company's common stock and are to be settled in cash and stock upon the Reporting Person's termination as a director of the Issuer. Balance reflects transactions reported on Form 5 as filed February 14, 2008.
