Each Common Unit acquired upon the conversion of an LTIP Unit is redeemable by the holder for shares of common stock of the Issuer on a one-for-one basis. LTIP units are generally not convertible until two years from the date of the grant.
- (6) LTIP Units converted into Common Units of limited partnership interest in DRLP according to terms described above.
- (7) LTIP Units vest in three equal installments beginning on February 10, 2017 and have no expiration date.
