- (1) Includes 9,000 restricted shares subject to vesting over time.  
The price reported represents the weighted average sale price of the shares disposed of. The actual sale prices ranged from \$70.72 to \$71.07. The Reporting Person has provided to the Issuer and hereby undertakes to provide upon request by the U.S. Securities and Exchange Commission Staff or a security holder of the Issuer, full information regarding the number of shares sold at each separate price.
- (3) The Company received the allocation for the 2012 plan year under the Reliance Steel & Aluminum Co. Employee Stock Ownership Plan ("ESOP") on May 30, 2013. The Reporting Person acquired 81 ESOP shares for the 2012 plan year.

In addition, the Reporting Person beneficially owns 32,000 restricted stock units subject to performance and service criteria.
