(1) The reporting person was granted 24,562 shares of common stock as a result of the company's achievement of certain performance criteria for 2010/2011 (the award was originally allocated to the reporting person as performance-based restricted stock units). 50% of the shares vested on the date of grant and the remainder will vest on 3/1/13.

(2) Represents shares reacquired to satisfy tax withholding obligations in connection with the vesting of (a) 21,000 shares of restricted stock granted to the Reporting Person on 3/2/09 (b) 4,688 shares of restricted stock granted to the Reporting Person on 3/1/10 (c) 5,184 shares of restricted stock granted to the Reporting Person on 3/1/2011 as a result of the company's achievement of certain performance criteria for 2009/2010 (the award was originally allocated to the reporting person as performance-based restricted stock units) (d) 4,019 shares of restricted stock granted to the Reporting Person on 3/1/11 and (e) 12,281 shares of restricted stock granted to the Reporting Person on 3/1/12 (see footnote 1).

(3) Each restricted stock unit represents a contingent right to receive one share of eBay's common stock.

(4) The reporting person received 84,000 restricted stock units subject to a four-year vesting schedule, vesting 25% on 3/1/10 and 25% each year thereafter. Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.
