BKF Capital may be deemed the beneficial owner of 2,998,064 shares of Qualstar, consisting of 2,075,701 shares owned directly by BKF Capital, and an additional 917,249 shares owned through BKF Holdings. Steven N. Bronson, as the Chairman, CEO and majority shareholder of BKF Capital, may be deemed to be the beneficial owner of the shares of Qualstar held by BKF Capital. Steven N. Bronson is the owner and an additional 57,700 shares of Qualstar.
