## Item 5.07 – Submission of Matters to a Vote of Security Holders

On May 2, 2012, the Annual General Meeting of Shareholders of Fresh Del Monte Produce Inc. (the “Company”) was held. A total of 55,508,318 Ordinary Shares, or 96% of the Ordinary Shares issued and outstanding as of the March 13, 2012 record date, was represented in person or by proxy. The proposals presented at the Annual General Meeting of Shareholders are described in detail in the Company’s Proxy Statement for the 2012 Annual General Meeting of Shareholders filed with the Securities and Exchange Commission on April 2, 2012. All of the nominees for director described in that proxy statement were elected to serve until the Company’s 2015 Annual General Meeting of Shareholders, and each of the other items considered at the 2012 Annual General Meeting was approved by the shareholders, pursuant to the voting results set forth below.

To elect three directors to serve until the Company’s 2015 Annual General Meeting of Shareholders.
