The remaining amount of 34,118 shares of Common Stock reported on this Form 3 consist of shares of Common Stock over which Mr. Onnink has voting rights but which

 - (1) are indirectly beneficially owned by Stichting Lety (a foundation, the beneficiaries of which are Mr. Onnink's children) by virtue of Stichting Lety's ownership of interests in Cinquecento B.V. Mr. Onnink disclaims beneficial ownership of such shares beneficially owned by Stichting Lety except to the extent of his pecuniary interest therein. The aggregate number of shares of Common Stock beneficially owned by Cinquecento B.V. is 1,941,738 shares.
 - (2) The shares of Common Stock reported on this Form 3 are held in escrow pursuant to escrow arrangements whereby a portion of such shares may be forfeited to satisfy indemnity or purchase price adjustment payments made to Issuer, or because certain time vesting conditions are not met.
