**Common Stock**

We are offering 3,068,095 shares of our common stock, par value \$0.001 per share, directly to selected institutional investors pursuant to this prospectus supplement and the accompanying prospectus. The common stock will be purchased at a price of \$7.50 per share. Assuming the sale of all 3,068,095 shares offered by this prospectus supplement and the accompanying prospectus, the offering will result in total proceeds (before expenses) to the Company of \$23.0 million. There are no underwriting or placement agent fees associated with the offering.

Our common stock is listed on The NASDAQ Capital Market under the symbol "ADX". On February 17, 2015, the closing sale price of our common stock was \$7.50 per share.
