Ms. McKeown and the Company executed a one year employment contract, to be renewed annually on approval from the Board of Directors, at an annual compensation of \$210 thousand dollars with benefits comparable to other officers of the Company. There are no family relationships between Ms. McKeown and any director, executive officer or person nominated or chosen by the Company to become a director or executive officer.
