INFORMATION REQUIRED IN REGISTRATION STATEMENT

Item 1. Description of Registrant's Securities to be Registered

The securities to be registered hereby are 9% Trust Preferred Securities (the "Preferred Securities") of Consumers Energy Company Financing IV ("CECo Financing IV"), a Delaware business trust. The Preferred Securities represent undivided beneficial interests in the assets of CECo Financing IV and are guaranteed by Consumers Energy Company ("Consumers"), a Michigan corporation, to the extent set forth in the form of the Preferred Securities Guarantee Agreement by Consumers to The Bank of New York, as Preferred Guarantee Trustee (the "Guarantee Agreement"). The Guarantee is incorporated by reference to Exhibit (4)(m) to the Registration Statement on Form S-3 and Consumers and the Amendment No. 1 on Form S-3/A to the Registration Statement on Form S-3 and the Amendment No. 1 to the Registration Statement on Form S-3 and the Amendment No. 1 to the Registration Statement on Form S-3 and the Amendment No. 1 to the Registration Statement on Form S-3 herein as the "Registration Statement" (Registration Nos. 333-89363 and 333-89363-02) filed with the Securities and Exchange Commission on October 20, 1999, and October 22, 1999, respectively. The particular terms of the Preferred Securities and the Guarantee are described in the Prospectus and the Prospectus Supplement which are incorporated by reference to the Registration Statement. The Prospectus, the Prospectus Supplement and the form of Guarantee are incorporated by reference herein as set forth in Item 2 below.
