On December 17, 2014, the Compensation Committee (the "Compensation Committee") of the Board of Directors (the "Board") of Cheniere Energy, Inc. (the "Company") recommended and the Board approved a change in the annual base salary for Charif Souki, the principal executive officer of the Company.
