("Ameriprise") that it owns to its shareholders of record as of the close of business on September 19, 2005. The distribution will be made to shareholders of American Express on a pro rata basis by means of a share dividend. On or prior to the distribution date, Ameriprise will recapitalize the Ameriprise common stock held by American Express such that American Express will distribute to its shareholders one share of Ameriprise common stock for every five shares of American Express common stock held by shareholders of American Express on September 19, 2005.
