The value of the SMCA is payable in cash following the reporting person's termination of employment with the Issuer and its subsidiaries.
- (6) Options to buy 7,169 shares become exercisable on 02/15/2018 and options to buy 7,170 shares become exercisable on each of 02/15/2019 and 02/15/2020.
